Supporting activities included business plan composition and editing, as well as market material and website design,

From 1980 to 1990, Ms. Harrison was also an Associate and Director of Business Development for the largest architectural/engineering company in the world: Hellmuth, Obama & Kassabaum, Inc. (HOK).
